1. **You must participate a minimum of 12 charity events throughout the year.**
Appearances and performances are scheduled based on your availability and you must complete a minimum of 12 events within 12 months. These events have no financial compensation.
2. **You must be available for rehearsals.**
Rehearsals are Tuesday and Thursday evenings from 7:00 pm - 10:00 pm. Rehearsals begin immediately after team selection.
3. **You must be available for a weekend long training camp.**
The 2008 training camp will take place on June 6, 7, and 8th.
June 6th: 6:00 pm - 10:00 pm
June 7th: 8:00 am - 6:00 pm
June 8th: 8:00 am - 2:00 pm
4. **You must attend all home games.**
Attendance is mandatory and includes games scheduled during Labor Day, Thanksgiving, Christmas, or New Years holidays. The 2008 schedule will be released in April.
5. **You must be available for a week long calendar photo shoot.**
The 2008 calendar shoot will take place in mid June. Dates to be determined. **A valid passport is required for travel.** If you do not have one, apply immediately.
